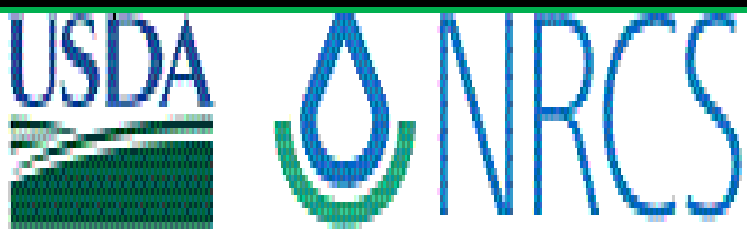

Environmental Quality Incentives Program (EQIP)

WHAT IS EQIP?

- **EQIP is a federal program managed by NRCS, under the US Department of Agriculture.**
- **EQIP is funded through the Farm Bill.**
- **The purpose of EQIP is to promote agricultural production, forest management & environmental quality**

What does this mean to private landowners?

- **Helps people manage private non-industrial forest lands.**
- **Focus is on improving and protecting forest conditions.**
- **\$\$\$ for Forest Management Plans and implementing forest practices.**

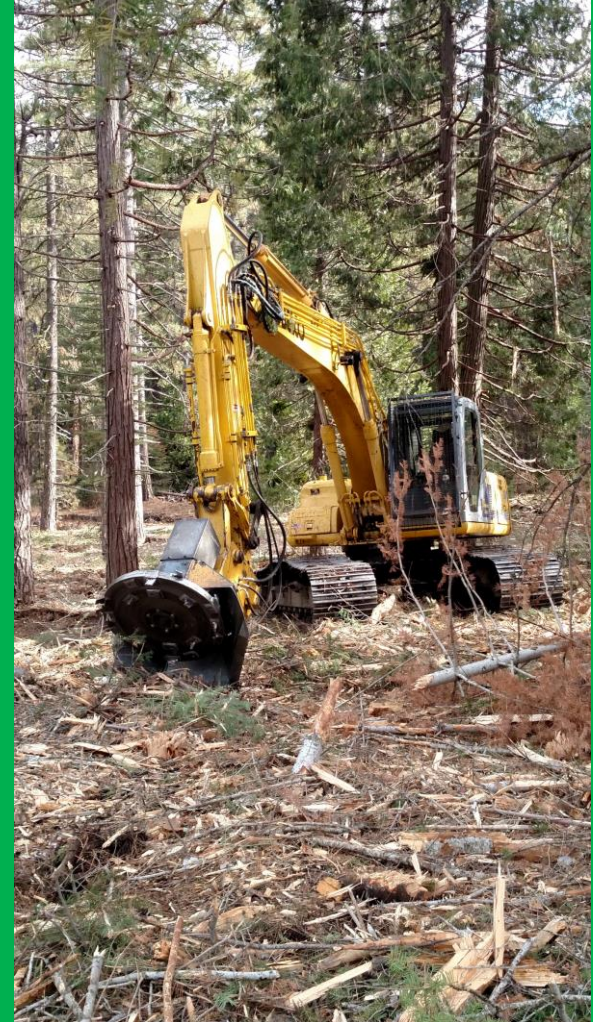

Forest Management Plan

- Both CAL FIRE (CFIP) and NRCS (EQIP) use same plan.
- EQIP can pay you to hire an RPF to write your plan.

This management plan outlines the conditions and capability of property resources, documents the landowner's objectives and decisions and identifies potential resource improvement projects. It is meant to be a flexible and educational document that considers a planning horizon of at least 5 years but may include objectives that require a much longer time period.

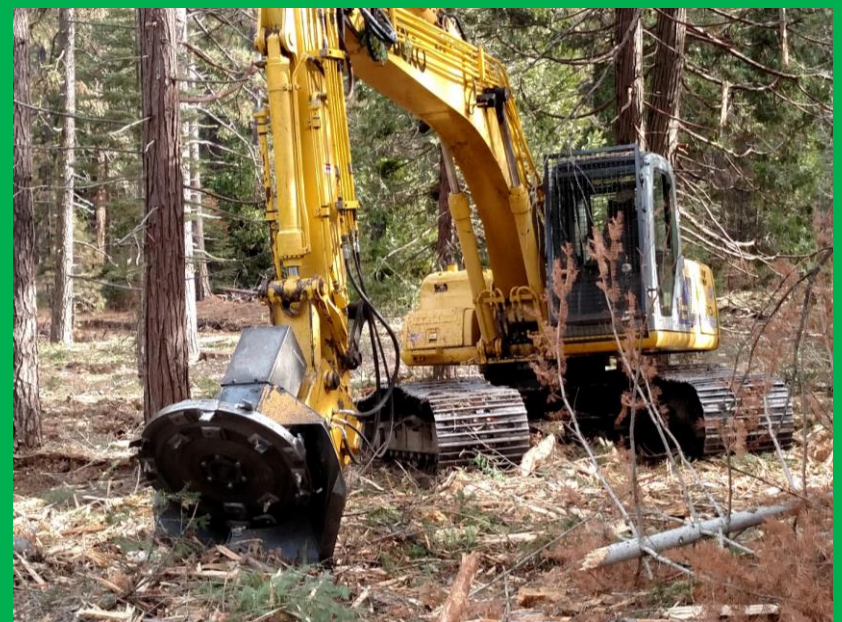
This management plan template meets management plan requirements for grant agreements and other provisions available through CAL FIRE, NRCS, USFS, and the American Tree Farm Association. Signature Pages are provided to document acceptance of this management plan in meeting those requirements.

This management plan is a tool for and belongs to the landowner. Signatures are only required for that entity providing funding as requested by the landowner.

Payment Rates

- **Pre set fixed Rate paid to Landowner**
- **Target 65% of actual cost paid to landowner's contractor**



Who can apply for EQIP Forestry Assistance?

- ❖ **Individuals, Tribes, Trusts, Non-Profits or other entities who own, lease or manage forested property.**
- ❖ **Gross income limit**
- ❖ **Excludes area 100 foot around structures.**

- **Forest Management Plan**
- **Apply for EQIP**
- **Sign Contract**
- **Do Work**
- **Get Paid**

- **NRCS - Technical and Financial Assistance for forestry practices**
- **Contact your local NRCS Field Office**
- **Submit an application, get a contract**
- **Hire and pay a contractor to do forestry work**
- **Be reimbursed for the work performed**
- **Maintain the work for a set period of time.**
